


# ACTING CHAIR'S MESSAGE

# TRUSTEE NEWS AND TOPICS



Dear Members,

I hope the recent bad weather has not prevented you from enjoying the activities of your U3A. It provided a bit of a challenge for our AGM workshop in Preston but most of the participants managed to reach the venue and we had some lively discussions.

January and February have rushed by with opportunities to visit networks and individual groups, meet at the NEC and attend workshops. With all the advice currently being distributed by National Office and the training for 'Keeping it Legal', one of the most frequent comments I hear is 'We're volunteers. We don't want all this bureaucracy being thrown at us!'

Consider this question: Do you want a U3A?

If so, then it is important to understand that every group is part of a growing organisation, but each group is operationally independent. This means that while you can manage many aspects of your U3A yourselves, you are still bound by two things. One of these is the fact that you have signed up to abide by the Objects and Principles of the Third Age Movement. The other is that each U3A is a charity. This means that your charitable status depends on following charity law, which means abiding by those objects and principles. The advice and training provided by the National Office and the Third Age Trust are designed to help you do just that.

After the problems created by charities in recent years, the Charity Commission is taking more interest in the activities of small charities such as ours. It's up to the members to support their committees in abiding by their constitutional requirements. If you are unsure of anything please don't hesitate to contact me. If I can't answer your query I can usually find some who can.

Like all the Regional Trustees, I am a volunteer too. I love my work because I know what a wonderful organisation we belong to.

# National Subject Advisors and Resource Centre



Are you aware that you can get advice and support from National Subject Advisors and from the Resource Centre at National Office? I recently attended a meeting of Subject Advisors where we discussed the sort of support they

could offer to interest groups in their subject but also how to develop that support by possibly creating support teams. There will be more discussion about this. The contact details are available via the National website or the Third Age Matters magazine.

### COMMITTEE REFERENCE FILE

The Committee Reference File is now being updated online. It can be reviewed and changed more easily this way, and with less expense. Committees will be told when significant updates are made and some may still come as hard copy.



This is an important and time consuming process but necessary to ensure that all our advice strengthens the progression of good

practice in accordance with Charity Law. If you need to check for information please look at the online file first to make sure that you have up to date advice.

#### National EGM

This meeting has been called to allow changes to the Memorandum and Articles of the Third Age Trust. This is the equivalent of a Constitution and is the Trust's governing document. U3As are members of the Trust and are invited to vote for the changes in the same way your own members are allowed to vote at your own AGM or EGM. The changes will not affect the management of individual U3As





but they will ensure that the Trust is compliant with Charity Law.

## Mission Statement and Strategic Plan

In order to develop a good level of support for our members, the Trust is developing a new strategic plan to help us follow our Mission statement which is 'to make lifelong learning, through the experience of U3A, a reality for all Third Agers': In accordance with the aims of the founders of the U3A movement in the UK, there are four overall goals:

1) Facilitate the growth of the U3A movement throughout the UK.

Third Age Trust (TAT) and National Office receive many requests for us to start U3As. Wherever possible we try to facilitate those requests.

# 2) Support learning in U3As and promote the benefits of self-help learning

Many U3A members have lost the learning focus, which is the main purpose of U3A under Charity Law. Learning may be formal or informal

3) <u>Provide advice and support for</u> management in U3As

We have a lot of advice, support and publicity material which is frequently reviewed and redeveloped.

4) Raise the profile of the U3A throughout the U3A.

It is amazing how many times people say they have never heard of us!

I would welcome your suggestions on how we might develop these goals. Your comments will be passed to the working party who will help to define and prioritise the best ways to proceed.

# New clause and social accounts Clarification:

The new object clause was developed to clarify the link between learning activities and social activities because the Charity Commission is now asking for ALL our accounts to be declared. It is all encompassing.

You are being advised to adopt this clause, whether or not you are registered with the Charity Commission. You are not obliged to adopt it but if your object clause does not cover the same objectives, then you can only do those stated in your constitution. For example if you only have the single object clause for learning then you risk running social events which may not be insured because they are unconstitutional. However the income from these activities will still be classed as part of your annual income, so if this takes you over £5,000 you will need to register with the Charity Commission.

### **Cottonopolis**

This project is now well underway. It was launched with a workshop event in January, organised

by the focus group of Jenny Carley, Tony Pearson and Maggie Simms who met the challenge of 'How are we going to do it?' Over 70 people registered to attend and were able to choose workshops on Textiles Fabrics: Urban and Drawing and Photography; Inventing Manchester; Social and Family History; Creative Arts; Transport and Social Conditions or the International Dimension. The speaker, Dr Mary Searle-Chatterjee from Lancaster U3A spoke about 'Lancashire Textiles and the India Connection'.

Participants could attend two workshops focusing on who, when and how one could take their idea forward, what resources they needed and what would be the possible outcome. At the end of the day they gather together to share their ideas, which ranged from: 'Looking at the life story of mill owners and their houses' to 'Looking at why Godfrey Cordial was sold, who made it, and why'.

Manchester University were invited but did not respond. Links have now been formed with Manchester Metropolitan University and the focus group now intend to expand that collaboration. Meanwhile the participants have gone back to their U3As to spread the word.



### SHARED LEARNING PROJECT

Through their support of and research into Far East Prisoners of War (FEPOW), the Liverpool School of Tropical Medicine(LSTM) have discovered that many of the prisoners documented their captivity in secret art work. They are planning an exhibition of this work at the University of Liverpool's Victoria Gallery 2019-2020 Museum in and anniversary of the end of WWII and the repatriation of survivors). ## FREQUENTLY ASKED QUESTIONS



#### Can visitors attend our U3A?

This depends on your committee. They can make a decision to allow visitors for a limited time, to give them chance to get a feel for the U3A. Most committees agree to two visits and ask for a small visitor's fee. Names of visitors should be recorded.

#### Can they come on outings?

Again, this is a committee decision. However if agreed, a visitor could attend a limited number of outings including an overnight trip. But to ensure that they are insured, their names should be noted and it is advisable to ask for a small payment for a temporary membership.

<u>Visitors would not be insured on a longer</u> holiday.
